	07.10.17	1) Impose a one percent consumer/use sales tax to make up the general fund revenue lost due to the adjustment of the B&O tax rates. 2) Privilege to permit the sale and service of beer, wine, and alcoholic liquors within the city beginning at 10 a.m. on Sundays, without the restrictions imposed on municipalities. 3) Utilize a request for proposal model when acquiring architectural and engineering services. Withdrawn on 07.25.17 4) Increase the appropriation of city funds not to exceed one dollar per capita per annum for advertising the municipality and the entertainment of its visitors. 5) Authority to execute agreements with other jurisdictions (intergovernmental agreements) by resolution. 6) Authority to enact a technology and maintenance fee against each person convicted within its Municipal Court. 7) Use a property owner opt-out approach under which the City can establish or expand a Community Enhancement District by municipal ordinance after public notice and hearing. Withdrawn on 07.25.17 8) Create a more reasonable and applicable standard lesser than “unfit for human habitation” as regards blighted or improperly maintained properties.
